Niki Stephanie Nichols, Superintendent of both the Big South Fork National River and Recreation Area and the Obed Wild and Scenic River and Acting Site Manager of the Oak Ridge unit of the Manhattan Project National Historical Park, will present information on the Manhattan Project National Historic Park and will ask for input concerning the project.

Prior to taking her current position, Superintendent Nichols served as Chief of Resources Management and Science at Yosemite National Park. She holds a BA in biology from Northwestern University, an MS in ecology from the University of Tennessee, and a PhD in forestry from the Virginia Polytechnic Institute and State University.

Notes from the President

Our state convention was in Memphis on March 31 and April 1. The theme was "Navigating the Future: Women in Leadership." Seven branches sent representatives. Martin and Memphis brought student affiliates, and there was a special session for them. Tennessee AAUW has 124 student affiliates. Traci Jensen, a national director, was one of our speakers. She brought an update on what is going on at HQ, including the "Barriers and Biases" research. She announced that AAUW will be releasing research on student loan debt in May. Voting in the national AAUW election begins April 17, and we are encouraged to vote. Candidate bios are on the aauw.org site. Our other key speaker was Beverly Watts, Executive Director of the Tennessee Human Rights Commission who spoke on women in leadership at the executive level by using the Wizard of Oz story to point out facets of leadership, pointing the way along the 'yellow brick' road. The Memphis Branch did a great job of hosting the Convention. They secured a cost-free location at Southwest Tennessee Community College- Macon Campus where we met in rooms at the library. Our hotel was next door to the college.

During the Business Meeting, state officers were elected – Dia Cirillo is President-Elect; Letha Granberry moves up to President and Phyllis Driver continues as Finance Officer. In other business, state dues were raised \$2 to \$12 beginning in July 2018. A state Leadership meeting will be held in Murfreesboro on June 3. Also Murfreesboro Branch agreed to host the 2018 state convention next Spring – date to be determined.

Our Branch is holding a discussion about our RSCC scholarships, pending whether the Legislature passes the required bill to grant free tuition to all community college students.

Lastly, it's time to select candidates for Branch officers for next year. The Board is acting as the Nominating Committee. The pressing need is for someone to serve as President because the other officers have agreed to serve another year. We must have nominees by April 24 because the election is at the general meeting April 24 and officers are installed in May to take office on July 1. If you have a candidate, please notify Peggy Emmett or one of the other Board members.

### Oak Ridge Branch AAUW Membership Renewal 2017-2018

Dues for 2017-2018 are due June 1, 2017. National dues are \$49, State dues are \$10, and Branch dues are \$9, for a total of **\$68**. Student Affiliate Dues are \$18. Part of the National Dues are tax deductible: \$46 for Regular Members and \$16 for Student Affiliate Members.

Paid Life Members are exempt from payment of National dues but continue to pay State and Branch dues (\$19). Fifty-year Life Members are exempt from payment of National, State, and Branch dues, although some continue to make contributions. Dues from new members joining after March 15 cover the next fiscal year.
