Mick Weist, Executive Director of the Oak Ridge Heritage & Preservation Association, will discuss how the remarkable history and heritage of Oak Ridge and this area are being captured and preserved for the future.

Mick is a native Oak Ridger. After living out of state for several years, Mick and his family moved back to Oak Ridge where he worked in the fields of conservation and environmental compliance. Mick earned a Bachelor of Science degree from the University of Houston and a Master of Science degree from the University of Tennessee, with a concentration in historic preservation. This prompted Mick to help found the ORHPA in 1999. The ORHPA is especially proud to share our remarkable history in the Oak Ridge History Museum, officially opening in March 2019. After 30 years of service at Y-12 performing environmental management duties and historic preservation projects, Mick stays active with part-time consulting, family activities, and volunteer work.
