In two Zoom meetings in January, which have now passed. One was on effective letter writing and the other had to do with helping with their activities. The decision of our Board was that individual AAUW MEMBERS who want to help the MOMs group should feel free to contact them.

The Board also decided that our Public Policy Committee could write a letter of concern to members of the state legislature about keeping arms locked away to protect children and keeping arms out of the hands of domestic abusers. When this letter is composed, it will be made available to members.

#### **Treasurer's Report**

Considering current conditions, the branch is in good financial shape, with donations and sales from the Gift Shop. A copy of the report given to the Board is attached.

A member has asked for clarification about tax deductible AAUW funds. The national organization has four of them: 4449 Economic Security Fund; 4450 Education and Training Fund; 4452 Leadership Fund; 4451 Governance and Sustainability Fund. 9110, the Greatest Needs fund is NOT tax de**ductible.** So, if a member wants to make a contribution to the national AAUW this is the choice of deductible funds. Sadly, our branch has had to make memorial contributions in the last month for Norma Woy and Alice Noggle. The contributions have been sent to the 4450 Education and Training Fund.

This brings us to the change which has now been made in the designation of our own educational fund the EOF (Educational Opportunities Fund.) It has been renamed NAF (National AAUW FUND) and will be used to make contributions to the National 4450 Educational Training Fund, which as has been stated is a 501 (c) (3) tax deductible fund. So, "NAF" will now appear in monthly treasury reports.

The LEP (Local Education Projects) continues with the present name. This fund is used to provide scholarships to Roane State students and other local education activities.

The Board decided this summer not to rollover one of our CD's with a value of \$500 + and to transfer this amount to the NAF fund. This amount is for the named gift to AAUW which the branch sends each year to National.

The proceeds from the Gift Shop of \$509 are going into the LEP fund. As a result of these two actions, we have adequate funding for both a scholarship and the designated, named gift.
